# Supply, Installation, Commissioning and Maintenance of CCTV Surveillance System at the Horizon Adult Remand Correctional Facility

#### Abstract:

The Government of Jamaica through the Ministry of National Security (MNS) is implementing the Security Strengthening Project (SSP) which is comprised of the following three (3) components:

- (i) Violent crime prevention and management;
- (ii) Improving investigative capabilities for homicides and;
- (iii) Change Management and Communications.

The Security Strengthening Project is aligned with the Sector Strategy on Institutions for Growth and Social welfare (GN-2587-2) and the Sector Framework for Citizen Security and Justice (OP-1201). The project is consistent with the 2016-2021 IDBG Country Strategy with Jamaica (GN-2868) and will contribute to the Corporate Results Framework (CRF) 2016-2019 (GN-2727-6) output indicators of: (i) Government agencies benefited by projects that strengthen technological and managerial tools to improve public service delivery; and (ii) Crime information systems strengthened. The project is also aligned with the 2017 Jamaica's Ministry of National Security Five Pillar Strategy for Crime Prevention and Citizen Security.

The Ministry of National Security *has received* financing from *the Inter-American Development Bank (IDB)*, and it intends to apply part of the proceeds to payments under the project Security Strengthening Project (SSP), for surveillance equipment for the Department of Correctional Services (DCS).

The Ministry of National Security now invites suitably qualified software vendors to submit bids for: Supply and Installation of Surveillance Equipment for the Department of Correctional Services (DCS)

### Scope of Work

The MNS/SSP/DCS proposes to procure the CCTV system for the Horizon Adult Remand Correctional Centre for monitoring and surveillance purpose, to include a purpose built monitoring facility at the facility and an off-site secondary monitoring site at the DCS' Head Office- King Street, Kingston.

#### Objective

The objective of this project is supplying, installing, commissioning and maintenance of CCTV without any damage as per specified configuration in this RFP at Horizon Adult Remand Correctional Centre. The bidder needs to submit the detailed supply and maintenance plan of the CCTV surveillance system. It shall cover the design of IP based surveillance system, supply, installation, commissioning followed by 2 years onsite comprehensive annual maintenance period (@ 6 month intervals).

### The Supplier will:

- Supply all the equipment specified in the requirements and specification.
- Install all the equipment specified in the requirements and specification as per manufacturer's instructions. All installations must be certified.
- Develop and execute the quality plan for Installation, testing the deployed network components
- Provide the requisite user acceptance training for the DCS staff

A vendor will be selected in accordance with the procedures set out in the Inter-American Development Bank: <u>Policies for the Procurement of Goods and Works financed by the Inter-American Development Bank</u> GN-2349-9 for International Competitive Bidding. The selection will also be in accordance with the procurement policies of the Government of Jamaica.
